

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [jiarenyogastudio.com](http://jiarenyogastudio.com), and Jiaren Yoga Studio and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jiaren Yoga Studio include [jiarenyogastudio.com](http://jiarenyogastudio.com), Jiaren Yoga Studio Vagaro Booking Site and <https://www.vagaro.com/jiarenyogastudio>. The Jiaren Yoga Studio website is a yoga studio information display and class booking site. By using the Jiaren Yoga Studio website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Jiaren Yoga Studio may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Jiaren Yoga Studio's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Jiaren Yoga Studio may also collect anonymous demographic information, which is not unique to you, such as your:

- SSL Protocol

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
